

ORDINANCE _____

AN ORDINANCE AMENDING THE CITY OF KILLEEN ZONING ORDINANCE BY CHANGING THE ZONING OF APPROXIMATELY 1.47 ACRES, BEING PART OF LOT 1, BLOCK 1 CRAWFORD-BOWERS SUBDIVISION NO. TWO, FROM “B-3” (LOCAL BUSINESS DISTRICT) AND “B-5” (BUSINESS DISTRICT) TO “B-3” (LOCAL BUSINESS DISTRICT) AND “B-5” (BUSINESS DISTRICT) WITH A CONDITIONAL USE PERMIT (CUP) FOR A CREMATORIUM; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Chapter 211 of the Texas Local Government Code and Section 31-39 of the City of Killeen Code of Ordinances, the City Council, upon application, may amend the City of Killeen Zoning Ordinance following a recommendation by the Planning and Zoning Commission and a public hearing;

WHEREAS, Jennifer Walker of JNW Architects, LLC, on behalf of SCI Texas Funeral Services, LLC, who is doing business as Crawford-Bowers Funeral Home, has presented to the City of Killeen, a request for an amendment to the City of Killeen Zoning Ordinance by changing the classification of approximately 1.47 acres of Part of Lot 1, Block 1 Crawford-Bowers Subdivision No. Two, from “B-3” (Local Business District) and “B-5” (Business District) to “B-3” (Local Business District) and “B-5” (Business District) with a Conditional Use Permit (CUP) for a crematorium;

WHEREAS, the Planning and Zoning Commission of the City of Killeen, following a public hearing on the 16th day of October 2023, duly recommended approval of the application for amendment, as described in the letter of request and site plan provided by the applicant;

WHEREAS, due notice of the filing of said request and the date of hearing thereon was given as required by law, and hearing on said request was set for 5:00 P.M., on the 28th day of November 2023, at the City Hall, City of Killeen; and

WHEREAS, the City Council at said hearing duly considered said request, the action of the Planning and Zoning Commission, and the evidence in support thereof, and the City Council being of the majority opinion that the applicant's zoning request should be approved as recommended by the Planning and Zoning Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KILLEEN:

SECTION I. That the zoning classification of approximately 1.47 acres, being part of Lot 1, Block 1 Crawford-Bowers Subdivision No. Two, from "B-3" (Local Business District) and "B-5" (Business District), to "B-3" (Local Business District) and "B-5" (Business District) with a Conditional Use Permit (CUP) to allow for a crematorium, as described in the letter of request and site plan provided by the applicant, on the property locally addressed as 1613 S. Fort Hood Street, Killeen, Texas.

SECTION II. That should any section or part of this ordinance be declared unconstitutional or invalid for any reason, it shall not invalidate or impair the validity, force, or effect of any other section or parts of this ordinance.

SECTION III. That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION IV. That this ordinance shall take effect immediately upon passage of the ordinance.
