Dear Mr. Wilson:

Bids were received for the "TAXWIAY B REHABILITATION" project at the City of Killeen, Purchasing Division, 802 N. 2nd Street, Building E in Killeen, Texas 76541 at 2:15 p.m. on May 3, 2022. The bid has been checked for accuracy and for compliance with the contract documents. A tabulation of the bids received is enclosed with this letter.

A total of one (1) bid was received on the project. TTG Utilities, Inc. submitted the lowest bid for the project with a total of \$10,529,774.63 for the base bids and all additive alternate schedules. The project includes 2 Base Bid schedules and two (2) additive alternates.

We believe that the bid submitted by TTG Utilities represents a good value for the Killeen-Fort Hood Regional Airport. The bidder stated they could not meet the DBE goal of 7.66% but has committed to 5.78% participation based on the total amount (Base Bids plus Additive Alternates 1 and 2). We believe the bidder provided a Good Faith Effort for DBE participation based on 49 CFR Appendix A. TTG Utilities' Good Faith Effort documentation is attached to this recommendation. Contingent upon Federal Aviation Administration funding, we recommend that the construction contract for the "TAXIWAY B REHABILITATION" be awarded to TTG Utilities.

As previously discussed with the Killeen Aviation Department, it is recommended that the following bid schedules be awarded: Base Bid A, Base Bid B, and Additive Alternate 1. The total construction contract value would be \$9,585,487.13. If funding allows for all bid schedules to be awarded, the total would be \$10,529,774.63.
