

WATER PRESSURE CONCERNS ALONG FEATHERLINE ROAD

- During a rezoning request for 195 acres on the westside of Featherline, several citizens issued low water pressure concerns.
- □ TCEQ 290.44(d) minimum water main pressure is 35 psi to be delivered to the water meter.
- City received calls related to low water pressure over past two years in three specific locations.
 - Shawlands Road
 - Cricklewood Drive
 - Aubrey Katherine Drive



- □ Shawlands Rd. calls began spring 2022
 - □ In August 2022, area was tied into Upper Pressure Plane
 - On April 12, 2024, staff tested and registered water main pressure at 80 psi and five houses along Shawlands at 65 to 80 psi at the water meter.

Background

- □ Cricklewood Dr. calls began summer 2023
 - □ From September 19 26, 2023, TCEQ monitored pressure and no violations were found.
 - On April 12, 2024, staff registered water main pressure at 50 psi and five houses along Cricklewood at 50 to 23 psi.
 - □ Upon further investigation, staff found pressure reducing valves(PRV) downstream of the water meters that were causing the drop in pressure at three homes; staff notified homeowners of the issue.

- Aubree Katherine calls began summer 2023
 - July 2023, three valves were adjusted and the watering schedule at the new high school was adjusted to off peak hours.
 - □ Summer 2023, staff continually monitored pressure in this area to make sure it stayed above 35 psi at the meter.
 - In January 2024, Chaparral EST was put in service.
 - □ April 12, 2024, staff registered water main pressure at 62 psi and five houses along Aubree Katherine at 60 to 63 psi.

- On May 3rd, city staff met with KDH and concerned citizens; water pressure at Shawlands Dr. was 64 psi, at Glynhill Ct it was 50 psi.
- Freese and Nichols will be evaluating the impact of a 600-home development on the westside of Featherline in the 2024 Water and Wastewater Master Plan.
- All tests performed on water pressures in the Featherline Rd.
 area are above 35 psi.
