The Condition of Homelessness is Very Costly

- a- Human tragedy affecting many individuals and their families.
- b- Creates major drain on local government resources.
- c- Overwhelms the criminal justice system (eg police, courts and jails).
- d- Overloads emergency rooms/departments.
- e- Diverts limited non-profit resources.
- f- Hurts and suppresses economic development.
- g- Frightens local residents.
 - > Overall Very Expensive on Many Levels.

If You Want, You Can Make Big Improvements!!

You can get real reductions in homelessness!!

- 1- Significantly Decrease Street-Level Homelessness.
 - 2- Reduce Jail Overcrowding.
 - 3- Reduce ER/ED Mis-use and Over-use.
 - 4- Significantly Increase Street Graduation Rates.
 - 5- Reduce the Rate of New Homelessness.

There Are Five Strategic Keys to Success – Think "Systems Approach" by Peter Drucker

- 1- In detail, understand your exact problems (eg scope, structure and scale).
- 2- Address the real root causes/triggers of homelessness, not symptoms.
- 3- To get big changes, you must make big changes.
- 4- Improve/change your service delivery system.
- 5- Change your community **CULTURE** from "enabling" to "engaging."

No Community Should Become Like Austin, Los Angeles nor San Francisco

Key Research Questions – Must Know the Scope, Scale and Structure to Address

- What is the "Homegrown" vs. "Out-of-Towner" ratio? Why do orgs have such different thinking on this issue?
- How long have people been experiencing homelessness?
- What is the job status pre/post the onset of homelessness?
- Identify consequential variances within the Bell County.
- Identify significantly important outlying data.
- What key services are lacking?

Big Picture Positives and Negatives

The Positives . . .

- Most people understand the connection with untreated mental illness and co-presenting substance use disorders.
- Description of the Governments, agencies and advocates are willing to work together (but there is no game plan nor system in place).

The Negatives . . .

- Almost no "formal system" of coordination.
- > Thin track record of system successes.
- Does not have the volume and inventory of needed services within Bell County.

Big Picture Positives and Negatives

Key Data Observations and Findings

Areas that are similar to would be expected . . .

- Age started experiencing homelessness (slightly lower).
- Age (slightly lower).
- Most individuals stay in one city.
- Race and ethnicity about what would be expected.

Key Data Observations and Findings

Areas that are different . . .

- Duration of homelessness "chronicness" (extremely high).
- Gender mix experiencing homelessness (many more females).
- Had a job before experiencing homelessness (very low).
- Do not have a job after experiencing homelessness (very low).
- And . . .

Key Data Observations and Findings

Home-Grown vs. Out-of-Towner . . .

High Out-of-Towner Metrics:

- > 15.7% born in Bell County.
- > 24.2% went to high school in Bell County.
- **▶** 41.5% had a job in Bell County BEH.
- > 43.5% have family currently living in Bell County.

Higher Home-Grown Metrics:

- ▶ 60.6% have or had (passed on) family living in Bell County.
- **▶** 64.7% started experiencing homelessness in Bell County.
