AN ORDINANCE AMENDING THE COMPREHENSIVE PLAN'S FUTURE LAND USE MAP BY CHANGING THE DESIGNATION OF APPROXIMATELY 2.376 ACRES, BEING LOT 1, BLOCK 2, OUT OF THE TRIMMIER ESTATES PHASE ONE REPLAT, FROM A NEIGHBORHOOD COMMERCIAL DESIGNATION TO A REGIONAL COMMERCIAL DESIGNATION; PROVIDING A SEVERABILITY CLAUSE; PROVIDING A SAVINGS CLAUSE; PROVIDING FOR THE REPEAL OF CONFLICTING PROVISIONS; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City of Killeen finds that section 213.003 of the Local Government Code enables municipalities to amend comprehensive plans in the interest of coordinating long-range development of the municipality;

**WHEREAS**, pursuant to section 31-39 of the City of Killeen Code of Ordinances, the City Council, upon application, may amend the Comprehensive Plan, including the Future Land Use Map (FLUM), following a recommendation by the Planning and Zoning Commission and a public hearing;

WHEREAS, Central Texas Development Services, on behalf of RSBP Developers, presented to the City of Killeen, a request for an amendment to the Comprehensive Plan's FLUM by changing the classification of approximately 2.376 acres, being Lot 1, Block 2, out of the Trimmier Estates Phase One Replat, locally addressed as 5310 Trimmier Road, from a Neighborhood Commercial designation to a Regional Commercial designation;

**WHEREAS**, the Planning and Zoning Commission of the City of Killeen, following a public hearing on March 24, 2025, duly recommended disapproval of the application for amendment;

WHEREAS, due notice of the filing of said request and the date of hearing thereon was given as required by law, and hearing on said request was set for 3:00 P.M., on May 6, 2025, at the City Hall, City of Killeen; and

**WHEREAS,** the City Council at said hearing duly considered said request, the action of the Planning and Zoning Commission, and the evidence in support thereof, and the City Council being of the majority opinion that the applicant's zoning request should be approved.

## NOW, THEREFORE BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KILLEEN, TEXAS:

**SECTION I:** That the future land use designation of approximately 2.376 acres, being Lot 1, Block 2, out of the Trimmier Estates Phase One Replat, locally addressed as 5310 Trimmier Road, be changed from a Neighborhood Commercial designation to a Regional Commercial designation.

**SECTION II.** That should any section or part of this ordinance be declared unconstitutional or invalid for any reason, it shall not invalidate or impair the validity, force, or effect of any other section or parts of this ordinance.

**SECTION III.** That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

**SECTION IV.** That this ordinance shall take effect immediately upon passage of the ordinance.
