Our estimate includes:

- Re Plank Upper Grandstand Bleachers – 8 rows by +/- 200 feet
- Full deck plank arrangement
- Anodized aluminum seats / anodized aluminum riser boards / mill finish treads as specified
- Anodized aluminum handrails at aisles locations
- Manufacturing (**AISC approved facility**) and shipping materials needed for complete installation
- Receiving and setting all of our aluminum planking.
- Installation at Non - prevailing wage rates
- Sealed shop drawings by state authorized engineer

Excludes:

- Any state or local sales taxes, permits, fees, etc. including state plan approval or fees
- Any bonds.
- Any indemnification for sole negligence and/or willful misconduct by the contractor or his contractors
- Any demolition.
- Any testing or inspections.
- Any costs of clean up crews provided by others.
- Any cutting or patching for other trades.
- Any liquidated damages.
- Any item not listed in above inclusions.

Notes:

- Site areas may be disturbed due to delivery of materials and installation. We have not included any costs to re-grade, reseed or repair any site areas disturbed during the construction of the bleachers.
- General contractor shall provide permanent bench mark and control points for grandstands/ bleachers locations and elevations.
- General contractor shall provide access to the site.
- General contractor shall provide staging area adjacent to jobsite for materials and equipment.
- Delivery drivers will be owner / operators.
- Southern will provide clean up of our debris to a central location to be removed by others.


