Approval of Agenda

Motion was made by Mayor Pro-Tem Blackstone to approve the agenda as written. Motion seconded by Councilmember Gilmore. The motion carried unanimously.

Minutes

Motion was made by Councilmember Rivera to approve the minutes of the April 14th Regular City Council Meeting. Motion was seconded by Councilmember Segarra. Motion carried unanimously.

Resolutions

RS-15-006 Consider a memorandum/resolution awarding Bid No. 15-11 for the Killeen Transportation-Street Services Stewart Neighborhood Project.

Staff comments: Scott Osburn

City staff recommends the City Council award a construction contract to Ambreco, LTD for the concrete improvements in the amount of \$196,226.50; award the asphalt paving bid to Alpha Paving Industries, LLC, in the amount of \$63,457.75; and further authorize the City Manager to execute all change orders within the amounts established by state and local law.

Motion was made by Mayor Pro-Tem Blackstone to approve RS-006. Motion was seconded by Councilmember Gilmore. Motion carried unanimously.

RS-15-007 Consider a memorandum/resolution authorizing Change Order No. 29 to the US 190/FM 2410/Rosewood Drive project with James Construction Group, LLC.

Staff comments: George Lueck

Change Order No. 29 is necessary to compensate the contractor for various west bound main lane detour repairs. The total cost of the west bound main lane repairs to date is \$94,297.22. Based on all factors, reasonable compensation to the contractor totals 60%, or \$56,578.33. Change Order No. 29 will increase the expenditure for the Project in the Pass-Thru Finance US 190/FM 2410/Rosewood Drive, General Obligation Bonds, US 190/FM 2410/Rosewood Drive Account. City staff recommends that the City Council authorize the City Manager to execute Change Order No. 29 with James Construction Group, LLC.

RS-15-008 Consider a memorandum/resolution authorizing the City Manager to submit a Transportation Alternatives Program (TAP) application to the Texas Department of Transportation (TxDOT) to construct a hike and bike trail.

Staff comments: George Lueck

With this grant application, the City of Killeen is proposing a three-mile (Segment 4) multiuse trail connecting the future residential KISD Elementary School location south to the US Government property in Bell County. The project budget estimates the total project construction costs of \$3,500,000. The City would provide approximately \$1,000,000 (29% of construction-related costs) and will be reimbursed \$2,500,000 (71% of construction project costs) as the project progresses. City Staff recommends that the City Council authorize the City Manager to submit a Transportation Alternatives Program application to the Texas Department of Transportation for the Heritage Oaks Hike and Bike Trail.

Councilmember Okray made a statement for the record. See attached.

The Community Development Staff briefed the Community Development Advisory Committee ("CDAC") on needed revisions to the CPP. The CDAC collectively reviewed and discussed the changed contents and provided final recommendations for the revised document on February 11, 2015. City Staff recommends adoption of the Citizen Participation Plan dated January 2015, as appropriate, with citizen comments to be presented to City Council.

Council meeting 4-28-15. Agenda item# RS-15-008 Councilmember Okray stated for the record the following:

My support of the TAP App is contingent upon emplacement of flexible revenue generating programs. No such programs exist at this moment in time. We only have the ability to match the TAP App through inter-loan ability from either the General Fund or through funds available in budgeted line items. What I understand regarding this consideration it that we will allocate funds to match this requirement with bond funding. I have a fundamental disagreement with that. Have we considered the Killeen Parks and Recreation Master Plan? Is this consideration included in the Plan? Are we exercising distribution of funding in similar fashion as the state, particularly having a project on the books for funding? Have we addressed funding needs of Parks identified in the Parks Master Plan? I believe I addressed a basic need of the AA Lane Neighborhood through a memorandum submitted May 14, 2014. I visited the park after our workshop last week and determined that the basic need of this operational park has not been met.

I spoke with a gentleman there conducting a baseball practice and he informed me that the tree line of the park is used to relieve themselves. I routinely communicate with another gentleman that utilizes the park for summer youth programs and found that the Chevron on the north right of way corner of east VMB and MLK is the place they use to relieve themselves. We need to remember and be concerned with the demographic that has long been established in the North Killeen by equalizing and managing North and South Killeen infrastructure funding priorities accordingly. I don't not support usage of bond funding that is required by this consideration, without an arrangements to fill the needs of AA Lane Park and other park in the Parks/Recreation Master Plan.
