# Background

- The City of Killeen is committed to providing a safe environment for our citizens and employees.
  - ▣ Three years ago, COK bought 13 AEDs (Automated External Defibrillators).
  - ▣ Lacked funds to maintain or replenish supplies.
  - ▣ The 13 AEDs did not cover all of the public buildings in the City.

# Background Continued

3

- A decision package was submitted and approved in the FY25 budget to remedy the funding issue.
- The City of Killeen sought bids to address two major concerns:
  - Purchase additional AEDs to increase coverage in high traffic public buildings (requested 11 additional AEDs);
  - Have a vendor in place to maintain the AEDs and replace expired items (i.e. pads).
