

ORDINANCE _____

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KILLEEN, TEXAS AMENDING THE FY 2013-14 ANNUAL BUDGET AND PLAN OF MUNICIPAL SERVICES OF THE CITY OF KILLEEN BY INCREASING VARIOUS GENERAL FUND EXPENDITURE ACCOUNTS IN THE AMOUNT OF \$414,429; INCREASING VARIOUS AVIATION FUNDS EXPENDITURE ACCOUNTS IN THE AMOUNT OF \$17,404; INCREASING VARIOUS SOLID WASTE FUND EXPENDITURE ACCOUNTS IN THE AMOUNT OF \$37,381; INCREASING VARIOUS WATER AND SEWER FUND EXPENDITURE ACCOUNTS IN THE AMOUNT \$49,288; INCREASING VARIOUS DRAINAGE UTILITY FUND EXPENDITURE ACCOUNTS IN THE AMOUNT OF \$12,492; AND INCREASING VARIOUS OTHER FUNDS EXPENDITURE ACCOUNTS IN THE AMOUNT OF \$16,399; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; PROVIDING FOR A SEVERABILITY CLAUSE; PROVIDING FOR PUBLICATION AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, a budget for operating the municipal government of the City of Killeen for the fiscal year October 1st, 2013, to September 30th, 2014 has been adopted by City Council in accordance with the City Charter, and

WHEREAS, the City of Killeen conducted a salary survey for all employees; and

WHEREAS, it was determined that the current salaries for the city were under the market; and

WHEREAS, it was the intent of the City Council of the City of Killeen to adjust the pay for all employees of the City of Killeen by 3%;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KILLEEN:

SECTION I. That Ordinance 13-067 adopting a budget for operating the municipal government of the City of Killeen for the Fiscal Year October 1, 2013 to September 30, 2014, be amended as to the portion of said budget as follows (See attachment, distributed to City Council on June 4, 2014.)

SECTION II. That the City Council finds that the public notice and public hearing requirements of Section 56 of the City Charter have been complied with prior to the enactment of this ordinance.

SECTION III. That should any section or part of any section or paragraph of this ordinance be declared invalid or unconstitutional for any reason, it shall not invalidate or impair the validity, force or effect of any other section or sections or part of a section or paragraph of this ordinance.

SECTION IV. That all ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION V. That this ordinance shall be effective after its passage and publication according to the law.
