On Wednesday, September 17, 2025, bids were opened for the above referenced project. Eight contractors submitted bids for this project. Freese and Nichols, Inc. (FNI) reviewed the bids for errors and omissions. All bidders acknowledged the addenda and provided bid security. A summary of the bids received is provided in the table below, and the detailed bid tabulation is attached.

The bids include a base bid for ductile iron pipe, a bid alternate number 1 for PVC pipe, a bid alternate number 2 for ductile iron pipe with auger boring under driveways, and a bid alternate number 3 with PVC pipe with auger boring under driveways. FNI and City Staff have determined that the base bid for ductile iron pipe provides the City with the best long-term value for the project.

The lowest base bid was \$9,981,018.00 submitted by Blackrock Construction.

FNI contacted Blackrock Construction's references to verify quality of work on past projects. These references included Kevin Jaeger (817) 357-4491 with the City of Cleburne, Jessie Ortiz (469) 363-1474 with the City of Mesquite, Walter Solley (254) 523-8620 with STV, and Ulyess Lopez (210) 643-6927 with San Antonio Water Systems.

FNI examined the bid proposals submitted for this project to check for errors or omissions. There were no errors or omissions in Blackrock Construction's bid. FNI found Blackrock Construction's bid is accurate and provided the lowest base bid for the construction of the project. Based upon review of contractor's references, and the bid price, it is recommended that the project be awarded to Blackrock Construction for the base bid amount of \$9,981,018.00.
