Budget Adoption

- Record Vote on Budget

Ratify Property Tax Revenue Increase

- Local Government Code 102.007(c)
 - Adoption of a budget that receives more property tax revenue than in the previous year requires a separate vote to ratify the property tax revenue increase
 - Total tax revenue increase is \$5,673,191 (8.81%)
 - M&O \$5,280,259
 - I&S \$392,932

Ratify Property Tax Increase

- Vote to Ratify Property Tax Increase

Setting the Tax Rate (cont'd)

- Property Tax Code 26.05(b)
 - Sets forth the following requirements if the tax rate exceeds the no-new-revenue rate:
 - Record Vote
 - Approved by at least 60 percent of City Council (5 members)
 - Motion to approve the ordinance must be made with specific language:
“I move that the property tax rate be increased by the adoption of a tax rate of \$0.6573, which is effectively a 9.62 percent increase in the tax rate.”
