

Opposition and Protest for City of Killeen Case Number Z24-29

We, the undersigned residents of the City of Killeen, TX, oppose and protest Case Number Z24-29 to rezone 87.44 acres of the W H Cole Survey, Abstract No. 200 (west side of Featherline Drive, west of the intersection of Malmaison Road) from "A" (Agricultural District) to "R-1" (Single-Family Residential District). In accordance with Sec. 211.006 (d) of the Texas Local Government Code, we affirm we own property within 200 or 400 feet of the rezoning location, and we understand this document will be submitted to the City of Killeen City Council.














