## TERMINATION OF TRUST

WHEREAS, the City of Killeen designated the members of the City of Killeen City Council to be Trustees and created an Employee Benefit Trust ("EBT") for the purpose of providing City officers, employees, and qualified retirees and their dependents with dental benefits directly or through the purchase of insurance in a Declaration of Trust dated July 27, 2010 ("Declaration of Trust");

WHEREAS, the creation of the EBT saved the city from paying taxes on premiums paid for employee insurance benefits;

WHEREAS, the tax savings are now insufficient to justify the continued cost of administration, the Trustees wish to terminate the Declaration of Trust and distribute the trust funds in a manner that is consistent with the purposes of the EBT;

NOW, THEREFORE, the Trustees do hereby terminate the Declaration of Trust as of the Effective Date below and provide for the disposition of remaining trust funds in the following order:

- 1. Payment of all obligations, debts, losses, and liabilities of the EBT;
- 2. Payment of covered claims of persons covered under the City's dental benefits plan;
- 3. Transfer to the City's Health/Dental Insurance Fund.
