Metrics and Projects


- Reviewed civil infrastructure plans for 49 new subdivisions (plats) and 51 new commercial development permits.
- Reviewed 16 land disturbance permit applications for coverage under TPDES Construction General Permit.
- Inspected public infrastructure construction within 51 active residential subdivisions (5 added within fiscal year).
- Inspected public infrastructure construction within 67 active commercial development projects.
- Provided resident project representation for 18 major capital improvement (bond) projects.
- Updated Flexible Pavement Design Procedures for Public Streets.
- Evaluated various future potable and reuse water supply options for the City



Solid Waste Services Noted Events/Projects

- Solid Waste "Killeen-Off" FY15:
 - Spring Clean Up: Tires 1,143; Waste 344.47 tons; Appliances 05
- Solid Waste Master Plan adopted by City Council 2/24/2015
- Routeware GPS, Fleet Tracking, Service Verification full implementation 11/10/2015
- Killeen Recycling Center Household Hazardous Waste February 2015 Event:
 - Cars 248; Tires 201; 1,800 lbs. of electronics
 - ▶ 150 lbs. batteries, 35 gallons antifreeze
- Fleet replacement program began with an initial purchase of 13 vehicles in FY15, continuing in FY16 with the purchase of 6 additional vehicles.

Elms Road Extension




Elms Road Extension - 95% Complete




