


DONATION OF FORMER FIRST NATIONAL BANK TEXAS BUILDING AWARD BID 22-36, DEMOLITION & ASBESTOS REMOVAL

Background and Findings


- Historically, the former First National Bank Texas of Killeen was chartered in 1901 and is the oldest continuously operated bank in Bell County. The main portion of the bank structure was constructed in 1960.
- The former First National Bank Texas has relocated its bank facilities to the new location at 901 E. CTE which officially opened on March 16, 2022.
- The plan is to donate this older bank property to the City of Killeen for site demolition and to prepare the lot for a new Bell County building complex to bring new life into downtown Killeen area.
- The city has requested bids for the removal of asbestos containing material and the removal of the entire building complex including the site improvements such as parking lots, fences, signage, etc.
- In preparation for this demolition, the City Council recently approved the removal of this property out of the HOD (historical overlay district) through Ordinance 22-046 on June 28, 2022.
