AN ORDINANCE AMENDING CHAPTER 28, TRAFFIC, ARTICLE IX, MISCELLANEOUS RULES OF THE CITY OF KILLEEN'S CODE OF ORDINANCES BY REPEALING CONSTRUCTION ZONE SPEED LIMITS AND ESTABLISHING THE MAXIMUM SPEED LIMIT ON CERTAIN DESIGNATED STREETS; PROVIDING A PENALTY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR A SAVINGS CLAUSE; PROVIDING FOR PUBLICATION AND AN EFFECTIVE DATE.

WHEREAS, the City of Killeen, Texas is a home-rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Texas Local Government Code; and

WHEREAS, construction has ceased on State Highway 195, U.S. Highway 190, U.S. Highway 190 frontage roads, and FM 2410 within the City limits; and

WHEREAS, the City Council of the City of Killeen deems it appropriate to repeal the construction zone maximum speed limits where no construction exists;

WHEREAS, Chapter 545 of the Texas Transportation Code authorizes the City of Killeen to alter by ordinance prima facie speed limits from the results of an engineering and traffic investigation; and

WHEREAS, the recommendations in the ordinance are based on completed speed studies (engineering and traffic investigations) performed by either City staff or TxDOT showing that any prima facie speed limit set by statute is greater or less than is reasonable or safe under the conditions found to exist, taking into consideration the width and condition of the pavement and other circumstances on that portion of roadway, as well as the usual traffic on it, in accordance with the Texas Transportation Code; and

WHEREAS, the City of Killeen seeks to exercise its lawful authority to enact all reasonable legislation for the promotion of public health, safety and welfare.

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KILLEEN:

SECTION I: That Chapter 28, Traffic, Article IX, Miscellaneous Rules of the City of Killeen Code of ordinances is hereby amended by repealing Sections 28-245, 28-246, 28-247, 28-248, 28-249, 28-250, 28-254, 28-255, 28-256, 28-257, 28-258, 28-259, 28-260, and 28-261 in their entirety and adding the following section to read as follows:

Section 28-245. - Speed Limits on Certain Roads.

The state traffic laws regulating the speed of vehicles shall be applicable upon all streets within this city except as this section, as authorized by state law, hereby declares and determines upon the basis of an engineering and traffic investigation that certain speed regulations shall be applicable upon specified streets or in certain areas, in which event it shall be unlawful for any person to drive a vehicle at a speed in excess of any speed so declared in this section when signs are in place giving notice thereof. The maximum speed limit shall be set forth upon those streets or portions thereof as follows:

(a) The reasonable and safe prima facie maximum speed limit shall be 20 miles per hour along the following streets:

SECTION II. That violating this Ordinance shall be an offense punishable according to the Texas Transportation Code.

SECTION III. That all ordinances or resolutions or parts of ordinances or resolutions in conflict with the provisions of this ordinance are hereby repealed to the extent of such conflict.

SECTION IV. That should any section or part of any section or paragraph of this ordinance be declared invalid or unconstitutional for any reason, it shall not invalidate or impair the validity, force or effect of any other section or sections or part of a section or paragraph of this ordinance.

SECTION V. That the Code of Ordinances of the City of Killeen, Texas, as amended, shall remain in full force and effect, save and except as amended by this ordinance.			
SECTION VI. That this ordinance shall be effective after its passage and publication according to law.
