Message from City Manager Ronald L. Olson

Creating stability in an unstable environment is a significant challenge. In city government, it is a multilayered challenge that must be addressed in the short- and long-term.

Short-term stability is achieved primarily through a balanced budget. The Fiscal Year 2018 Budget was developed and adopted with expenditures planned to fit within available revenue. While not all requests could be afforded, allocations were made to ensure accomplishment of departmental primary missions. This report details those accomplishments and the achievements made possible by the hard work of City staff.

Long-term stabilization is a more difficult endeavor. It starts with fully understanding the pressures and issues that are causing instability. I have identified a number of those factors and have worked with City Council to begin creating solutions.

Diagnosing the root causes of financial stress took some time, but we have now pinpointed several strategic issues. Per capita revenue has been declining over the last decade in large part because of the disproportionate impact of veterans exemptions. The City has consequently been maintaining levels of service by deferring needs like street and building maintenance. It has also been undercompensating employees and underfunding their retirement. While none of these will cause failure today, each becomes more costly when deferred and ultimately leads to catastrophic consequences. We have made some progress with street maintenance and employee compensation, but there is much more work ahead.

Policy is a major contributor to creating a stable environment. A policy creates structure and direction that can withstand changes in conditions and leadership. Through the diligent work of city Council and staff, we have successfully implemented a number of policies including financial, governance, capital improvement and economic development. These provide clarity and focus toward defined expectations.





GENERAL FUND SUMMARY



The City's annual FY 2018 Budget ended September 30, 2018. Expenditures were made within allocations resulting in an average fund balance in major operating funds of 27%.

The General Fund, which funds public safety, quality of life and general government functions, ended the year with an estimated 27% fund balance. By policy, the amount exceeding 22%, about \$2 million, will be transferred into the Capital Project Fund.
