

**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE BY THE CITY COUNCIL OF THE CITY OF KILLEEN, TEXAS, CANVASSING RETURNS AND DECLARING THE RESULTS OF A GENERAL ELECTION HELD MAY 1, 2021 FOR THE ELECTION OF A DISTRICT COUNCILMEMBER FOR DISTRICT 1, DISTRICT 2, DISTRICT 3 AND DISTRICT 4 AND CANVASSING RETURNS AND DECLARING THE RESULTS OF A RECOUNT HELD MAY 11, 2021 FOR THE ELECTION OF A DISTRICT COUNCILMEMBER FOR DISTRICT 4.**
