On October 6, 2017 the KFD transitioned from Zoll EMS reporting system to ESO's software to submit reports for medical calls due to the customization capabilities and ease of using the program. During this time, Killeen FD has continued to use Zoll Fire RMS, however, the program has become incompatible with fire department needs. ESO Solutions is a single source provider of Fire RMS software compatible with ESO's EMS/Medical RMS software. The KFD recommends amending the original agreement with ESO Solutions (approved by City Council in September of 2017 through CCMR 17-103) to add the Fire RMS software to the current Master Subscription and License Agreement.

Purchasing division justification:

ESO Solutions, Inc. software was procured in 2017 for the EMS reporting module based off of a single/sole source justification. Surrounding hospitals and the county also use the ESO Fire RMS software which has made the current software used by FD no longer compatible. The ESO Fire RMS software is a single source. Amending the current agreement to add the Fire module will allow for compatibility and interchangeability with existing software/hardware, will standardize the RMS solutions, and help with maintaining the historical data and connections to the county CAD system. ESO Solutions Inc. has been deemed a sole/single source in Austin, TX, Fort Hood, TX and Davie, FL.
