## **Approval of Agenda**

<u>OR-20-031</u> - AN ORDINANCE ELECTING FOR THE CITY TO MAKE CURRENT SERVICE AND PRIOR SERVICE CONTRIBUTIONS TO THE CITY'S ACCOUNT IN THE BENEFIT ACCUMULATION FUND OF THE TEXAS MUNICIPAL RETIREMENT SYSTEM AT THE ACTUARIALLY DETERMINED RATE OF TOTAL EMPLOYEE COMPENSATION.

Motion was made by Councilmember Rivera to approve consent agenda items. Motion was seconded by Councilmember Johnson. The motion carried unanimously.

### **Public Hearings**

**PH-20-041 HOLD** a public hearing and consider an ordinance amending the FY 2021 Annual Budget of the City of Killeen to increase expenditures in the General Fund.

The City Secretary read the caption of the ordinance. AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KILLEEN, TEXAS, AMENDING THE FY 2021 ANNUAL BUDGET OF THE CITY OF KILLEEN TO INCREASE EXPENDITURES IN THE GENERAL FUND; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; PROVIDING A SAVINGS CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

#### Staff Comments: Jon Locke, Executive Director of Finance.

Initial estimates for legal services relating to failing road work on Stagecoach Road and Lowes Boulevard have increased due to the need for expert witness services which have significantly exceeded the original estimates. This budget amendment will increase expenditures by \$425,000, bringing the total estimated legal expenses to \$925,000. City staff recommends city council approve the ordinance amending the FY 2021 annual budget.

Mayor Segarra opened the public hearing.

With no one appearing, the public hearing was closed.

Motion was made by Councilmember Nash-King to approve PH-20-041. Motion was seconded by Councilmember Fleming. Motion carried unanimously.

**PH-20-042 HOLD** a public hearing to provide citizens the opportunity to comment, and City Council to discuss and consider a resolution approving the Interlocal Agreement

and application of the Edward Byrne Memorial Justice Assistance Grant (JAG) for FY 2020.

**Staff Comments:** Assistant Chief Jeff Donohue, Police Department. Through an interlocal agreement, \$74,921 in 2020 JAG funds will be awarded and distributed to the Killeen Police Department, Temple Police Department, and the Bell County Sheriff's Department. The Killeen Police Department will receive \$37,835 and will utilize the funds to help improve audio/visual equipment for enhanced training at the department's police academy, as well as, enhance the crime fighting efforts of the Organized Crime Unit. City staff recommends city council authorize the city manager or his designee to approve the submission of the 2020 Edward Byrne Memorial Justice Assistance Grant through the Killeen Police Department; and to permit the Killeen Police Department to allocate and administer the duties required by the grant under the oversight of the Finance Department.

Mayor Segarra opened the public hearing.

With no one appearing, the public hearing was closed.

Motion was made by Councilmember Rivera to approve PH-20-042. Motion was seconded by Councilmember Nash-King. Motion carried unanimously.
