EFFECTIVE DATE.

Motion was made by Councilmember Brown to approve the consent agenda. Motion was seconded by Councilmember Williams. Motion carried unanimously.

#### Resolutions

**RS-21-010** Consider a memorandum/resolution declaring vacancies on various citizen appointed boards and commissions and appointing members to fill the unexpired terms.

Staff Comments: Traci Briggs, City Attorney.

Ms. Briggs reviewed the recommended appointments that were made during the previous week's workshop meeting and recognized Councilmember Brown and Councilmember Wilkerson's recommendation to appoint Mr. Leo Gukeisen to the second vacant alternate position on the Zoning Board of Adjustment. City staff recommends city council declare vacancies on various citizen appointed boards and commissions and appoint citizen members to fill the identified unexpired terms, and to appoint members to the reinstated Capital Improvement Advisory Committee.

Motion was made by Councilmember Wilkerson to approve RS-21-010 as presented. Motion was seconded by Councilmember Harris. Motion carried unanimously.

RS-21-008 Consider a memorandum/resolution authorizing a professional services agreement with Randall Scott Architects, Inc., in the amount of \$543,825 for the Killeen Community and Senior Center Project.

**Staff Comments:** Joe Brown, Executive Director of Recreation Services. With no changes to the presentation from last week's workshop meeting, city staff recommends city council authorize the city manager to enter into a professional service agreement with Randall Scott Architects, Inc. in the amount of \$543,825 and that the city manager is expressly authorized to execute any and all changes within the amounts set by state and local law.

Motion was made by Councilmember Wilkerson to approve RS-21-008. Motion was seconded by Councilmember Williams. Motion carried 5 to 1 with Councilmember Brown in opposition.

**RS-21-012** Consider a memorandum/resolution amending the 2021-2022 State Legislative Priorities and Principles.

**Staff Comments:** Hilary Shine, Executive Director of Communications City council unanimously approved the 2021-2022 State Legislative Priorities and Principles October 20, 2020. City council made a motion of direction at its January 19, 2021 workshop meeting to amend the document by adding the following priority: The city of Killeen will seek legislative action to allow Killeen municipal elections in November. City staff recommends that city council approve the amendment of the 2021-2022 State Legislative Priorities and Principles.

Motion was made by Mayor Pro Tem Fleming to approve RS-21-012. Motion was seconded by Councilmember Wilkerson. Motion carried 5 to 1 with Councilmember Nash-King in opposition.

RS-21-013 Consider a memorandum/resolution confirming the City Auditor's annual evaluation and pay increase.

Motion was made by Mayor Pro Tem Fleming to approve RS-21-013. Motion was seconded by Councilmember Nash-King. Motion carried 5 to 1 with Councilmember Brown recorded as a vote in opposition by abstaining from the vote.

### **Public Hearings**

**PH-21-007 HOLD** a public hearing and consider an ordinance amending the FY 2021 Annual Budget of the City of Killeen to authorize the carry forward of FY 2020 expenditure budgets to the FY

2021 budget and adjust revenue and expenditure accounts in multiple operating, special revenue, internal service, and capital improvement project funds.

The City Secretary read the caption of the ordinance.

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KILLEEN, TEXAS, AMENDING THE FY 2021 ANNUAL BUDGET OF THE CITY OF KILLEEN TO AUTHORIZE THE CARRY FORWARD OF FY 2020 EXPENDITURE BUDGETS TO THE FY 2021 BUDGET AND ADJUST REVENUE AND EXPENDITURE ACCOUNTS IN MULTIPLE OPERATING, SPECIAL REVENUE, INTERNAL SERVICE, AND CAPITAL IMPROVEMENT PROJECT FUNDS; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT WITH THIS ORDINANCE; PROVIDING A SAVINGS CLAUSE; AND ESTABLISHING AN EFFECTIVE DATE.

**Staff Comments:** Jon Locke, Executive Director of Finance.

Mr. Locke presented a very brief summary of the proposed budget amendment identifying that there were no changes to the presentation from last week's workshop meeting. City staff recommends city council approve the ordinance amending the FY 2021 annual budget.
