### **BACKGROUND AND FINDINGS:**

The Bipartisan Infrastructure Law, signed into law on November 15, 2021, provides \$15 billion in Airport Infrastructure Grants over a five (5) year period for airport-related projects as defined under the existing Airport Improvement Grant and Passenger Facility Charge (PFC) criteria.

The City has been offered a Federal Aviation Administration (FAA) Airport Infrastructure Grant in the amount of \$108,810 to fund 90% of the design of the Security Improvements Project at the Killeen-Fort Hood Regional Airport. Matching funds, in the amount of \$12,090, will come from the FAA PFC Application that was approved by the FAA on February 16, 2023.

Acceptance of this grant requires the City to make assurances related to the continued availability of the Airport to the public and compliance with a number of federal regulations and standards.

### **THE ALTERNATIVES CONSIDERED:**

1. Do not accept the grant.
2. Accept the grant.

**Which alternative is recommended? Why?**

Alternative 2 is recommended because:

The project is 100% funded by the Grant and PFC funds; and there is no impact on the Airport operating fund or fund balance.

The expenditure for FY2023 is \$120,900.
