SUBJECT: **Authorize the Acceptance of 24 Tracts of Land Comprising Sections of FM 439**

BACKGROUND AND FINDINGS:

The Texas Department of Transportation (TxDOT) Right of Way office undertook an effort to clean up some administrative transfers for sections of FM 439 from 16th Street to 38th Street and north from there along Westcliffe Road (Old FM 439) to the present FM 439 (East Rancier Avenue). The City of Killeen has been maintaining these sections of roadway for a number of years. An administrative oversight failed to offer the deeds for these properties at such time that we originally started maintaining said ROW.

THE ALTERNATIVES CONSIDERED:

The City considered two alternatives for this item:

- 1) Decline to accept these portions of roadway and continue to maintain them without ownership.
- 2) Accept these tracts and eliminate possible confusion in the future.

Which alternative is recommended? Why?

It is recommended that the City accept these tracts of land for the following reasons:

1. These tracts are within the city limits and not maintained by the state.
2. These tracts comprise roadways that the City currently maintains.
3. It eliminates administrative confusion and makes the record consistent.

CONFORMITY TO CITY POLICY:
