BACKGROUND AND FINDINGS:

On September 8, 2017, the Killeen Arts Commission voted to reduce the board by two public-at-large positions due to excessive vacancies and absenteeism. The Killeen Arts Commission is requesting to revise its Rules and Regulations to reduce the number of members to nine (9) effective October 1, 2018.

THE ALTERNATIVES CONSIDERED:

- 1. Revise the Killeen Arts Commission rules and regulations reducing the Commission to nine (9) members
- 2. Do not revise the Killeen Arts Commission rules and regulations reducing the Commission to nine (9) members.

Which alternative is recommended? Why?

The Killeen Arts Commission voted to approve Option #1 due to the lack of attendance which results in quorum issues.
