# **BACKGROUND AND FINDINGS:**

City of Killeen Governing Standards and Expectations sets forth direction that state legislative principles shall be adopted by City Council to quide representation of City interests at the state level.

A formal list of state legislative priorities and principles was developed to enumerate specific actions we will pursue and general positions we will take during the 87th legislative session. City Council unanimously approved the 2021-2022 State Legislative Priorities and Principles October 20, 2020.

City Council made a motion of direction at its January 19, 2021 Workshop to amend the document by adding the following priority: The City of Killeen will seek legislative action to allow Killeen municipal elections in November.

The amended 2021-2022 State Legislative Priorities and Principles document will be provided to state representatives of the City of Killeen and other legislators or agencies with an interest in issues that affect the City. It will also be provided to our state legislative consultant to guide work on our behalf.
