BACKGROUND AND FINDINGS:

The City was offered an Airport Improvement Program (AIP) Grant in the amount of \$5,444,499 to fund the majority of the Taxiway B Rehabilitation project at the Killeen-Fort Hood Regional Airport (KFHRA). The matching funds will come from the FAA approved Passenger Facility Charge (PFC) Application that was approved by the Federal Aviation Administration (FAA) on July 13, 2021.

Staff has negotiated a professional services agreement with Garver, LLC, in the amount of \$889,100 for the construction administration services, on-site resident project representative services, materials testing services and project closeout services for this project at KFHRA.

THE ALTERNATIVES CONSIDERED:

Alternatives considered: (1) do not approve the agreement, or (2) approve the agreement

Which alternative is recommended? Why?

Staff recommends alternative 2. The FAA requires professional experienced oversight and documentation of the construction process. The Garver team is the Airport engineer of record and was selected via a competitive process. This choice offers the most experienced team fully cognizant of all FAA requirements for projects at KFHRA.

The amount of the expenditure for professional services is \$889,100.
